

IN MEMORIAM

PROFESSOR RUDOLF BIĆANIĆ

It is bad news, indeed, to announce the death of Professor Rudolf Bićanic, a distinguished scholar and member of the International Association for Research in Income and Wealth since its very beginning. He died in Zagreb, Yugoslavia, on July 9, 1968.

Professor Bićanić was born in 1905 and graduated at the Law Faculty in Zagreb where he obtained his doctoral degree. In the 1930's he was especially concerned with peasant economics and politics in Croatia. Within the framework of this research he organized sample surveys of economic and social conditions of Croatian peasants.

Before the outbreak of the second World War he was appointed Secretary for Foreign Trade in the Yugoslav Government. The war years he spent in London with the Yugoslav Government in exile, holding the post of First Deputy Governor of the National Bank of Yugoslavia.

Immediately after the war he returned to Yugoslavia and was appointed to act as the Yugoslav representative at a number of international conferences in 1945. Since 1946 he had been professor at the Law Faculty of the University of Zagreb, holding the chair of economic policy. As professor he displayed remarkable activities in teaching and applying modern methods of economic analysis.

The opus of Professor Bićanić, a very gifted and industrious scholar, consists of over 200 items—books, articles, comments, etc.—published in Serbo-Croat, English, French, Italian, and other languages. His first study dates back to 1931, and he was active in research until his death. He contributed valuable learned papers at many international conferences of various associations.

The research opus of Professor Bićanic covers a broad range in the social sciences. It is not confined to economics, but covers also a number of sociological and political topics as well. Throughout his work are interwoven numerous lucid ideas contributing to the present stock of knowledge and stimulating further research by other scholars.
