*IARIW Special Conference on Environmental Accounting*  
*March 5-8, 1996, Tokyo, Japan*

The Economic Planning Agency of the Japanese Government and the United Nations University located in Tokyo will co-host a Special Conference on Environmental Accounting under the auspices of the International Association for Research in Income and Wealth (IARIW). The conference will take place from March 5 through 8, 1996. The EPA will be host the 5th and 6th and the UNU will be host the 7th and 8th.

The conference is intended to be a follow-up of the IARIW Special Conference on Environmental Accounting which took place in Baden, Austria, in 1991. The focus will be to exchange information on individual country experience in implementing the SEEA (System of Environmental and Economic Accounting) proposed by the United Nations Statistical Office in 1993.

The EPA is responsible for compiling the SNA and the SEEA, and is an Institutional Member of the IARIW.

The IARIW Special Conference format will be applied wherever possible, i.e. a small conference with intensive discussion, formation of a follow-up scheme, among others. The sessions are expected to cover the development of the SEEA, experiences in both developed and developing countries, theoretical issues such as valuation of environmental assets and production boundary and asset boundary, and data needs from an analytical as well as a policy point of view.

The Members of the IARIW are welcome to participate.

The *Nancy Ruggles Memorial Fund* provides a grant for one person to attend the General Conference of the International Association for Research in Income and Wealth. The next conference will be held in Lillehammer, Norway, August 18 through 24, 1996. The grant will be awarded competitively on the basis of a paper judged by the Trustees of the Fund.

Applicants for the grant should:

\* Submit to the IARIW Secretariat an unpublished single author original paper on a subject relevant to the interests of the Association. (See the inside cover page of the *Review* for the address and a description of the Association's fields of interest.) A C.V. should accompany the paper. The deadline for paper submissions is **February 15, 1996**.

\* Be working, on a permanent basis, in a country outside Western Europe, North America, Japan, Australia and New Zealand.

\* Be under 35 years old.

The grant is intended to contribute to the cost of airfare, conference fees and hotel accommodation up to a limit of US \$2,500. The successful applicant will be expected to present his, or her, paper at the Conference.
